Holloway's booklets (dated 1911 and 1917) do not give the  
date of Julia's ['Juda'] death. Zerelda thinks Joshua and  
family left Virginia and located in or near Lexington, Ky.

John Watts married Nancy Hudson; with Joshua Hudson as surety.  
February 17, 1808. "Consent of parent personally given."  
Fayette Co., Ky.

[Nancy may be another sibling. Joshua's wife was Ann and  
the name Nancy is another form or nickname for Ann.]

John Hudson married Tammy Williamson, with William Williamson  
as surety. Sept. 14, 1808. "Consent of parent personally  
given." Fayette Co., Ky.

[Zerelda booklets state that John married 13 year old Tamar  
Williamson. He taught her to be a good housekeeper, etc.  
but she eventually died of lung trouble.]

wife of Caroline Co., Va. to Phillip Hudson of Essex Co.,  
for the sum of 100 pds - a certain parcel of undivided land  
lying in Fluvanna Co. containing 400 acres - 1/3 of said land
