 and place she does not know that her
 said husband was in the Battle of the
 River Raisin & was there taken Prisoner
 & was kept as a prisoner of war for
 several months she thinks that he

Husband was discharged in the year 1812 and returned home in March of that year. She says that her husband obtained a land warrant for and in account of the services of resaid and sent his discharge to the proper office, at Washington to obtain his land warrant and the same has not been returned to her. She refers to the same to supply the omissions in this declaration. She says that she was married under the name of Fanny Cox to said Samuel Hicks on the day of May 1813 by George Eves a minister of the Baptist Church, at the residence of John Cox in Fayette County Ky there being no legal barrier to said marriage. That her said Husband died on the 4th day of April 1861 and that she has not married since his death; that at no time during the late Rebellion against the authority of the United States did she or her said Husband adhere to the cause of the enemies of the Government living them aid or comfort or exercised the functions of any office whatever under any authority.

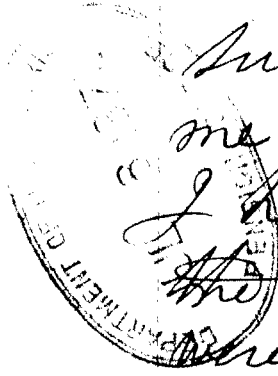

Declaration to be made by a surviving Officer or Soldier claiming additional Bounty Land.

On this 9th day of April 1855 before me, a Justice of the Peace in and for the County and State aforesaid, personally appeared Samuel Hise aged 63 years, who being duly sworn according to law, declares that he is the identical Samuel Hise who was a Private in the company commanded by Captain John Hamilton in the 10th Regt of the 1st Regiment of Volunteers commanded by Col. William Lewis in the War with Great Britain in 1812 That he

at Pine River Fayette County in the State of Kentucky on or about the day of September 1812 and was honorably discharged at Lexington Ky on or about the day of September 1813. He refers to his discharge on file in Washington among the proof sent previously. He further states that he has received for said service Bounty Land Warrant No. 80 acres, issued under the act of September 28th 1850, by reason of said service which he has since legally disposed of and cannot now return.

He makes this declaration for the purpose of obtaining the additional Bounty Land to which he is entitled under the Act of March 3d, 1855, never having received Bounty Land except as above stated, and he hereby constitutes and appoints Robert Brundage Williams of Washington, D. C. his Attorney to prosecute his claim and procure his warrant. Hereby authorizing and empowering his said Attorney to obtain from the proper authorities at Washington City or elsewhere, certified copies of any Army records or documents, in which his said service may be recorded, and to procure any and all other evidence that may be necessary to establish his claim, as fully as he might or could do if personally present, and revoking and countermanding all other authority that may have been given for the above specified purpose.

NOTE.

All Officers or Soldiers who have received a Land Warrant, or Land Warrants, for less than one hundred and sixty acres, under any act of Congress, are entitled, under the act of March 3, 1855, to additional Bounty Land, sufficient to make the aggregate one hundred and sixty acres—provided their service can be proved by record evidence.
Widows and minor children who have received less than one hundred and sixty acres of Land, are entitled to additional Bounty Land, provided the widow is a widow at the time of her application, and the children are minors at the date of the act, and provided the service of the soldier can be proved by record evidence.

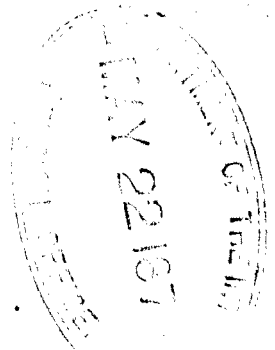
